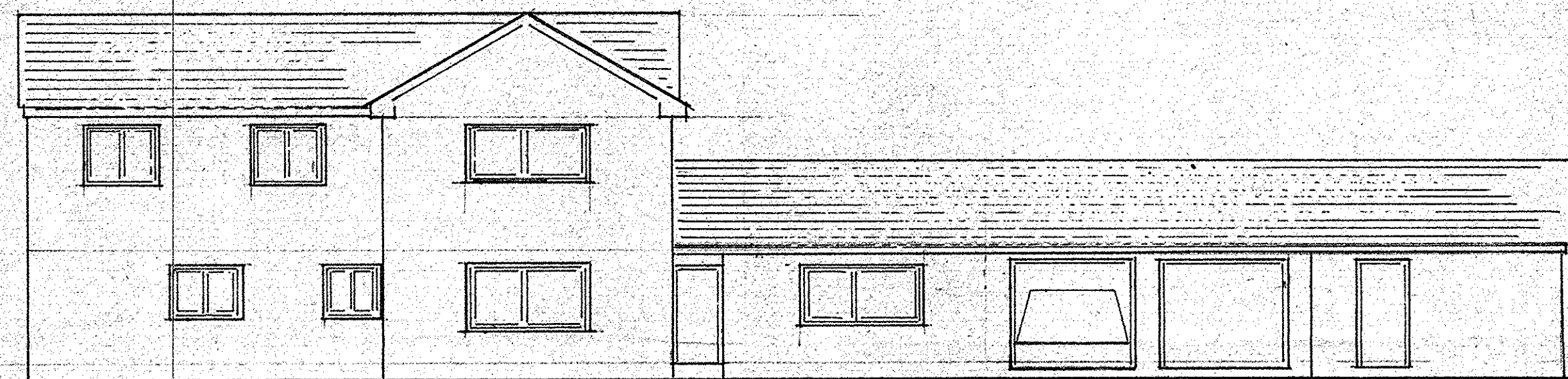

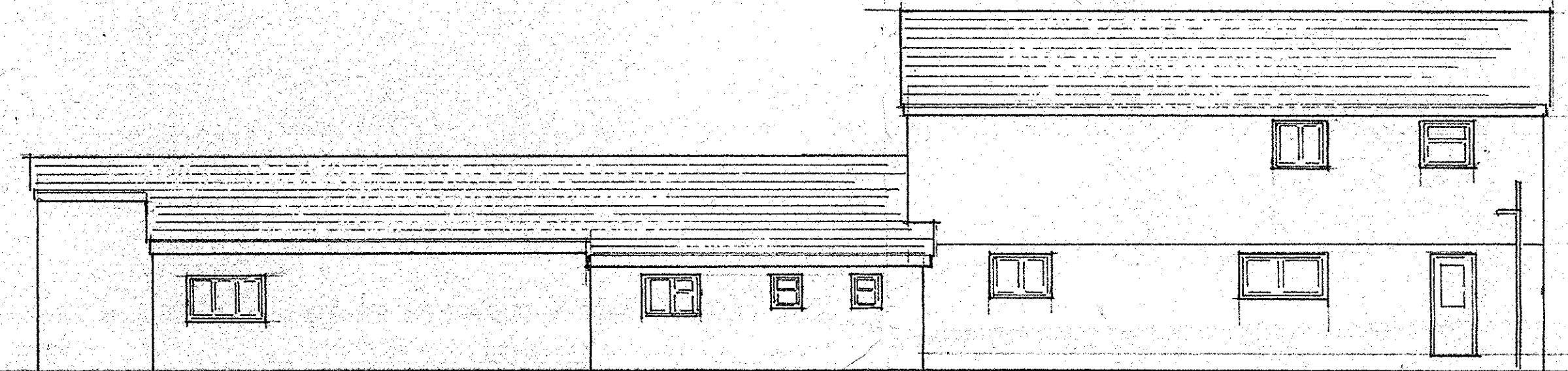
SITE PLAN 1:200



NORTH WEST

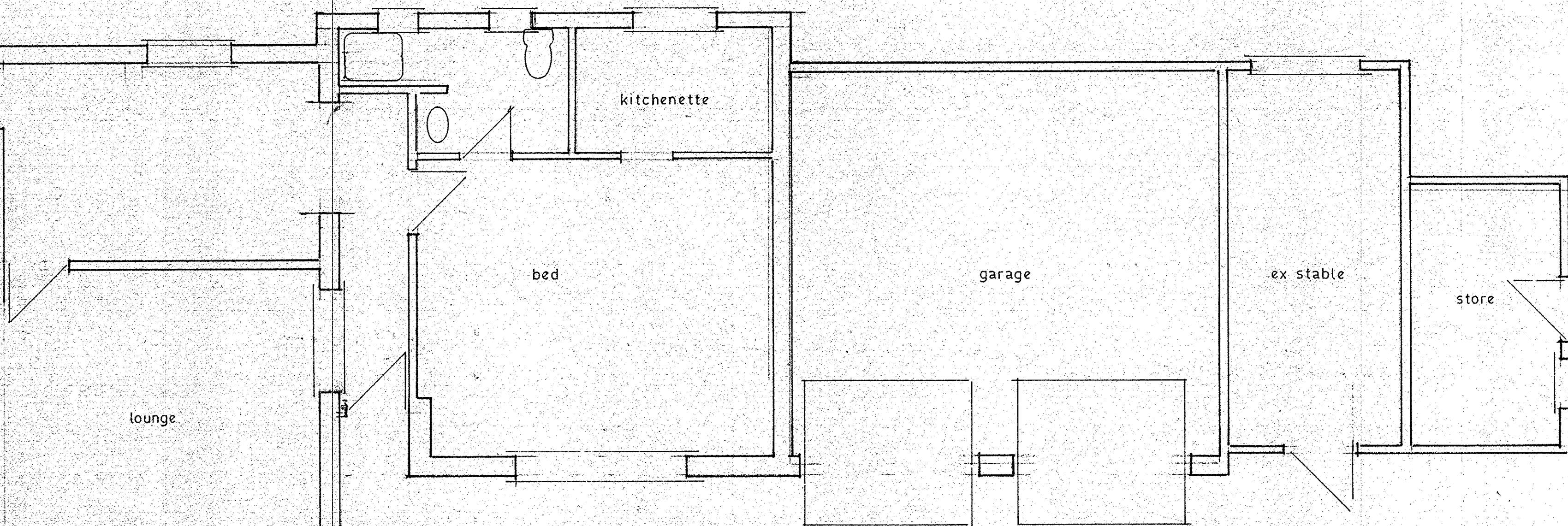


NORTH EAST

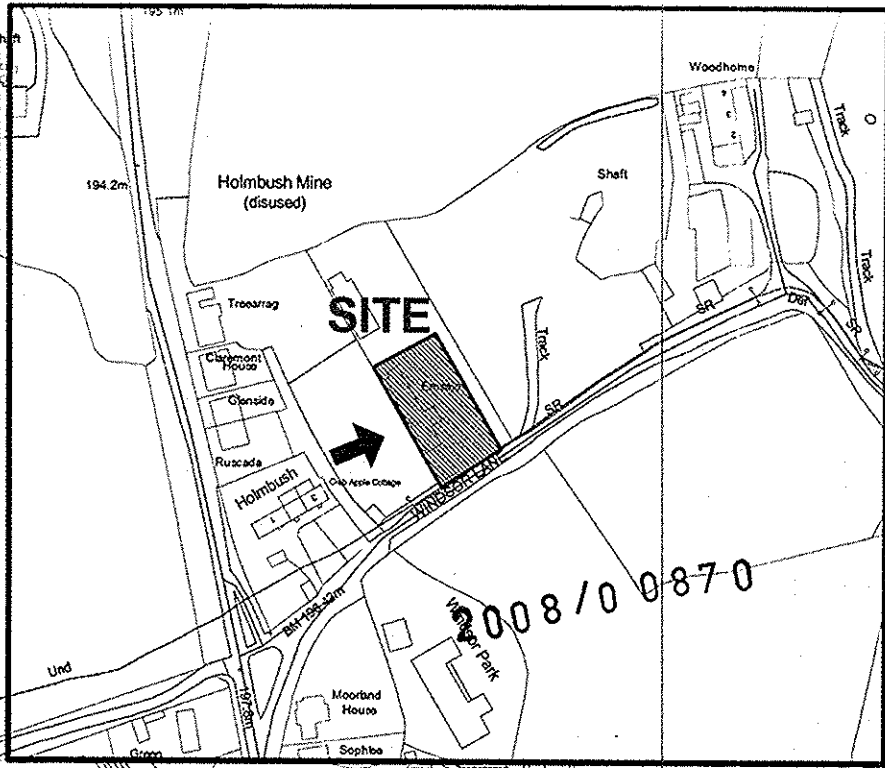
