SC 09/7/1 Apologies for Absence

A report was noted regarding the adoption of the road at Kyl Cober Park. It was agreed the clerk would write to Cornwall Council for confirmation of an update on this matter

SC 09/7/4 Minutes of Previous Meeting held on Monday 15th June 2009

It was noted that A Counsell should be included in application no 2009/00757. 2009/00732 M Joll seconded the application. Subject to the minor amendments, the minutes of the meeting held on 15th June 2009 were signed by the Chairman as a true record of the meeting.

- a) Applications for post of parish councillor - update - it was noted that there are 3 candidates for the 2 vacancies of parish councillor. It was noted that Cornwall Council is responsible for the administration of the election.
